Dear Madam Speaker:

I am seeking the assistance of your office to apply pressure upon the U.S. Department of Justice to timely comply with the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing agency guidelines of the U.S. Department of Justice (DoJ)

Enclosed please find a “canned” letter from the DoJ concerning approximately 1,000 pages of evidence I have sent to ex-Attorney General Alberto Gonzalez concerning two central issues:

- Mortgage fraud committed by members of the Adventology cult in Placer County, California; and,
- The possible subsequent cover-up of said mortgage fraud scheme by Rep. John T. Doolittle’s (Placer County) interference with federal investigators.

I contend that the DoJ is deliberately delaying a response to my FOIA request to “buy time” concerning revelations that Alberto Gonzalez was informed of the purported misconduct of Rep. Doolittle by me on dozens and dozens of occasions.

I respectfully request that a Congressional letter of inquiry be sent to the DoJ on my behalf to apply pressure upon the DoJ to comply with operative federal laws (FOIA).
